## **COMMERCIAL PRODUCTS LIMITED WARRANTY**

### **FIVE (5) YEAR LIMITED WARRANTY - ELECTRONIC PRODUCTS**

Gerber Plumbing Fixtures LLC (Gerber) warrants to the original purchaser of electronic products that they will be free from defects in material and workmanship under reasonable use for a period of five (5) years from the date of original purchase, as shown on the original purchaser's receipt.

### **TWO (2) YEAR LIMITED WARRANTY - MECHANICAL FAUCETS**

Gerber warrants to the original purchaser of mechanical faucets that they will be free from defects in material and workmanship under reasonable use for a period of two (2) years from the date of original purchase, as shown on the original purchaser's receipt.

### **ONE (1) YEAR LIMITED WARRANTY - VITREOUS CHINA**

Gerber warrants to the original purchaser that all vitreous china products and the included components will be free from defects in material and workmanship under reasonable use for a period of one (1) year from the date of original purchase, as shown on the original purchaser's receipt.

As the exclusive remedy for any breach of the above warranties, Gerber agrees, at Gerber's option, to repair or replace these products or any parts thereof, which prove, upon inspection by Gerber, to be defective in material or workmanship during the above stated periods of warranty coverage.

Gerber will not be liable for any labor, shipping, freight, or any other costs or charges incurred in connection with removal or replacement of the product or otherwise acting upon the above warranties, or for any costs associated with repair or replacement of any other personal property, building or installation materials. Installation or use of the product not in accordance with product instructions, or improper use, abuse or neglect of, or accident to the product, or moving the product from the location of its original installation will void the above warranties. Damage to the finish or performance of any components caused by the use of cleaning solvents/chemicals or improper cleaning methods (i.e. in-tank bowl cleaners) will also void the above warranties.
